- The undersigned agree that the corporation and the individuals are liable personally, jointly and severally for any and all debt with Jepson Petroleum (Alberta) Ltd.
- Terms of sale are End of Month. Jepson's preferred method of payment is an ABW (attached), online banking, or cheque. Payment is due by the **27<sup>th</sup>** of the following month. Agents or representatives of Jepson are not authorized to change credit terms without written authorization of the credit manager.
- The Applicant will immediately notify the Wholesaler in writing of any future changes to the information contained herein.
- All claims against invoices must be made within THIRTY (30) days of receipt of the goods or services.
- Accounts not paid by due date are subject to an interest charge from date of maturity at the rate of TWO PERCENT (2%) per month (equivalent to TWENTY SIX POINT EIGHT TWO PERCENT (26.82%) per annum). The Wholesaler reserves the right to put the applicant on "COD only" terms if any statements remain unpaid after FORTY-FIVE (45) days.
- N.S.F. Cheques or Pre Authorized Debits will be subject to a \$50.00 service charge.
- Failure to comply with these Terms and Conditions may result in the cancellation of credit privileges without notice. In the event of any default, Jepson, may close the account and / or accelerate payment of the full balances.
- This Agreement shall be governed by and construed in accordance with the laws of the Province of Alberta and the laws of Canada applicable therein. All claims and disputes arising out of or in any way connected with this Agreement shall be brought in the courts of Alberta and the courts of appeal therefrom.
- The Applicant agrees to bear all costs incurred in collecting any unpaid amounts, including but not limited to collection suit fees, legal and court fees.
- The information given in the Application and Agreement is warranted to be true and correct and given of the purpose of obtaining credit.
- The Applicant consents to the obtaining of credit and / or personal information as may be required in connection with the credit line hereby applied for, or any renewal or extension thereof and to the disclosure of any trade information concerning the applicant to any credit reporting agency or to any person with whom the applicant has or proposes to have financial relations.
